I. STATEMENT

1. The captioned rulemaking proceeding was commenced on January 15, 2004,

when the Colorado Public Utilities Commission issued its Notice of Proposed Rulemaking

(NOPR). See, Decision No. C03-1454. The NOPR set this matter for hearing on March 22 and

23, 2004.

2. On March 9, 2004, procedures were adopted that allowed for the bifurcation of

this proceeding. See, Decision No. R04-0239-I. Those procedures contemplated that the

March 22 and 23, 2004, hearing dates would be used by the Staff of the Commission (Staff) for

the purpose of summarizing the proposed rule changes and responding to participant questions

concerning the same. They also contemplated that a subsequent written comment filing deadline

and additional hearing dates would be established so participants could, among other things,

incorporate Staff's summary into their comments. Notwithstanding the above, it was recognized

that participants who did not wish to participate in this bifurcated procedure would be given an opportunity to submit their comments on the hearing dates established by the NOPR.

- 3. The undersigned administrative law judge (ALJ) called the matter for hearing at the assigned times and place. Appearances were entered by or on behalf of the following participants: Staff; Harvey V. Mabis; Metro Taxi, Inc.; Yellow Transportation, LLC; RDSM Transportation, doing business as Yellow Cab Company of Colorado Springs and Greater Colorado Springs Transportation Company; San Miguel Mountain Ventures, LLC, doing business as Telluride Express (Telluride Express); Alpine Express, Inc. (Alpine Express); Alpine Taxi/Limo, Inc. (Alpine Taxi); Rocky Mountain Repossessors Association; Recovery One; John F. Hafer, doing business as A Custom Coach (Custom Coach); Denver Lincoln Limousine, Inc. (Denver Lincoln Limousine); Colorado Corporate Coach, Inc. (Colorado Corporate Coach); and Pratt Adjustment Bureau.
- 4. During the course of the March 22 and 23, 2004, hearings Exhibits 1 through 4 were identified and marked for identification purposes.<sup>1</sup> Staff presented its summary of the proposed rules and all participants were afforded an opportunity to question Staff concerning the same. Oral comments were submitted by Telluride Express, Alpine Express, Alpine Taxi, Rocky Mountain Repossessors Association, Recovery One, Custom Coach, Denver Lincoln Limousine, Colorado Corporate Coach, and Pratt Adjustment Bureau.


