I. STATEMENT

- 1. On June 14, 2004, the Staff of the Colorado Public Utilities Commission filed a Motion to Consolidate Docket No. 04G-061EC with Docket No. 04G-194EC (Motion to Consolidate) and for Shortened Response Time (Motion to Shorten) in the captioned proceedings.
- 2. The Motion to Consolidate requests that both these civil penalty assessment matters be consolidated for hearing purposes. Docket No. 04G-061EC is currently scheduled for hearing on July 1, 2004. *See*, Decision No. R04-0637-I.
- 3. The Motion to Shorten requests that response time to the Motion to Consolidate be shortened to June 18, 2004.

- 4. Since the normal 14-day response time to the Motion to Consolidate expires shortly before the currently scheduled hearing date in Docket No. 04G-061EC, it is appropriate to shorten the response time in order to resolve that motion in a timely manner. *See*, 4 *Code of Colorado Regulations* 723-1-22(b) (Commission may shorten the time for filing a response to a motion). Therefore, the Motion to Shorten will be granted, in part.¹
- 5. Any desired responses to the Motion to Consolidate shall be filed on or before June 21, 2004.

- Any desired responses to the Motion to Consolidate Docket No. 04G-061EC with Docket No. 04G-194EC filed in these matters by the Staff of the Colorado Public Utilities Commission shall be filed on or before June 21, 2004.
