## I. STATEMENT

- 1. On July 22, 2004, WWC Holding Co., Inc., filed an Unopposed Motion for Extension of Time to File Answer Testimony (Motion for Extension) and for Waiver of Response Time (Motion for Waiver) in the captioned consolidated proceeding.
- 2. The Motion for Extension seeks an extension of time, through and including July 27, 2004, for Intervenors to file their answer testimony and exhibits in this matter. That filing is currently due on July 23, 2004. *See*, Decision No. R04-0713-I.
