I. STATEMENT

- 1. The captioned applications of Eastern Slope Rural Telephone Association (Eastern Slope) and Agate Mutual Telephone Cooperative Association (Agate) are currently scheduled for hearing on August 13, 2004. Rebuttal and cross-answer testimony and exhibits are currently due to be filed on or before August 4, 2004. *See*, Decision No. R04-0713-I.
- 2. On July 29, 2004, counsel for Eastern Slope and Agate informally advised the undersigned administrative law judge (ALJ) that a family emergency required that the hearing be continued and that the deadline for submission of rebuttal and cross-answer testimony and exhibits be extended.
- 3. On July 30, 2004, the ALJ was informally advised by counsel for all parties that August 18, 2004, was an acceptable date for a rescheduled hearing and that August 11, 2004, was an acceptable date for filing rebuttal and cross-answer testimony and exhibits.
