I. STATEMENT

- 1. The captioned proceeding is currently set for hearing on November 2, 2004. *See*, Decision No. C04-1086.
- 2. On October 13, 2004, Staff of the Public Utilities Commission (Staff) filed its Motion to Vacate and Reschedule Hearing (Motion). The Motion seeks to have the hearing vacated and rescheduled to December 15, 2004, or as soon thereafter as possible. As grounds therefore, Staff states that its counsel is occupied with numerous other previously scheduled matters before the Commission and, therefore, has insufficient time to prepare for and attend the November 2, 2004, hearing.
- 3. On October 15, 2004, Administrative Law Judge Kirkpatrick granted Staff the opportunity to supplement a similar motion filed in Docket No. 04C-465T for the purpose of providing additional information concerning Staff counsel's unavailability for a hearing

scheduled in that matter on November 1, 2004. See, Decision No. R04-1207-I. On October 21,

2004, Staff submitted its Supplement to the Motion (Supplement) in Docket No. 04C-465T. The

Supplement indicates that Staff's counsel is representing Staff in hearings currently scheduled in

Commission Docket No. 03A-436E on October 26, 2004, and in Docket No. 04A-254T on

October 28 and 29, 2004. This additional information provided adequate justification for the

continuance requested by Staff in Docket No. 04C-465T and, as a result, provides adequate

justification for the continuance requested in this matter as well. See, Decision No. R04-1250-I.

4. Therefore, the Motion will be granted. The hearing will be re-scheduled for

December 17, 2004, and the procedural schedule previously established by Decision No. C04-

1086 will be modified as set forth in the Order that follows.

II. ORDER

A. It Is Ordered That:

1. The hearing of this matter scheduled for November 2, 2004, is vacated.
