- Item 500 Special Bus Rates apply in the transportation, in special bus service of passengers and their baggage for purposes of several occasions and events:
- A. between all points in the Counties of Routt and Moffat, on the one hand, and the Bob Adams Field also known as the Steamboat Stolport, on the other hand; and
 - B. between all points in the area comprised of the Counties of Moffat and Routt, Colorado, on the one hand, and on the other hand,
 - 1. all points within a 5-mile radius of the intersection of U.S. High No. 40 and Colorado State Highway No. 9 at Kremmling, Colorado; and
 - 2. all points within a 5-mile radius of the intersection of Colorado State Highway No. 131 and the Colorado River at or near State Bridge, Colorado.

Restrictions: Restricted (1) against the transportation of train crews originating or terminating at actual train locations on rail sidings; and (2) to vehicles with a rated seating capacity not exceeding 15 passengers, plus the driver, and manufactured by or for Ford, Dodge, Plymouth, GMC, or Chevrolet.

All rates apply from the time a vehicle departs from its home terminal in Steamboat Springs, Colorado until the vehicle returns to its home terminal in Steamboat Springs, Colorado.

Rates: In vehicles of 15 passengers or less, including the driver \$65.00 per hour, subject to a 2 hour minimum

Rates: In vehicles of 16 passengers or more, including the driver \$85.00 per hour, subject to a 2 hour minimum

Rates: Round trip or one-way fares between Steamboat Springs, Colorado and State Bridge, Colorado \$25.00 per person
