**ORDER OF SUMMARY SUSPENSION AND
COMPLAINT AND NOTICE OF HEARING**

You are hereby notified that the Commission is in receipt of a cancellation notice from your insurance or surety company to cancel your insurance or surety coverage as noted below.

A transportation carrier must have active insurance or surety coverage on file with the Commission at all times.

Unless proper evidence of insurance or surety coverage is received in this office by April 17, 2015, your transportation carrier authority or operating right is summarily suspended effective on that date. All operations under such authority or operating right must cease on and after April 17, 2015, until proper evidence of insurance or surety coverage is filed with the Commission. The Commission finds that the public health, safety, or welfare imperatively requires summary suspension in order to protect the traveling public. Failure to comply may result in the imposition of civil penalties.

Please also be advised that this constitutes a complaint to permanently revoke your transportation carrier authority or operating right as a result of your failure to maintain proper evidence of insurance or surety coverage on file with the Commission. A hearing regarding the complaint is presently scheduled to be held on April 28, 2015, at 12:00 PM, 1560 Broadway, Suite 250, Denver, Colorado 80202. If the Commission receives proper evidence of insurance or surety coverage prior to the hearing, it will dismiss the complaint and vacate the hearing without further notice. Otherwise, you may appear at the hearing and submit written data, views, and arguments showing why your transportation carrier authority or operating right should not be revoked.
