I. **BY THE COMMISSION**

> A. **Statement**

This Decision opens an administrative proceeding as a repository for 1.

presentations and other materials relating to the High Cost Support Mechanism (HCSM) and the

funding to telecommunications providers for the provision of basic voice service.

2. A Commissioners' Information Meeting (CIM) is scheduled for November 9,

2017, starting at 10:00 a.m. Staff is directed to work with interested stakeholders to finalize an

agenda for the CIM.

В. **Discussion**

3. In recent years, significant legislation reforming Article 15 of Title 40 addressed

telecommunications services (Telecom Reform Legislation). Among its revisions, the Telecom

Legislative Reform established two primary purposes of the HCSM: (a) to provide financial

assistance for basic service in rural, high cost geographic support areas;² and (b) to provide

access to broadband service through broadband networks in unserved areas.³ The 2014 Telecom Reform Legislation precludes the Commission from providing HCSM support to providers for basic voice service in areas found to have effective competition.⁴

- 4. Section 40-15-509.5(3), C.R.S., states that the Commission may allocate HCSM funds⁵ for the deployment of broadband service in unserved areas of the state only from moneys that it determines are no longer required by the HCSM to support universal basic service through an effective competition determination made pursuant to § 40-15-207(b), C.R.S.
- 5. From 2014 through 2017, through multiple proceedings, the Commission has declared 104 wire centers to be effectively competitive and allocated over \$12 million in funding for the deployment of broadband services.
- 6. In consolidated Proceeding Nos. 15M-0158T and 14M-0947T, the Commission made findings of effective competition, in addition to establishing HCSM support amounts to be paid to specific providers of basic voice service in high cost areas for the calendar years 2015, 2016, 2017, and 2018. Although there is pending litigation challenging some aspects of the Commission's determinations,⁶ there are no pending matters currently before the Commission regarding the HCSM generally.
- 7. Given current determinations, it is likely the Commission will need to consider what HCSM funding structure for basic voice service may be appropriate and necessary going

forward after December 31, 2018. Without currently pending matters before the Commission,

we find it appropriate to hold a CIM.

8. We open this proceeding as a repository for informational materials and

presentations relating to the HCSM and funding of basic voice service in high cost areas. A CIM

is scheduled for November 9, 2017, starting at 10:00 a.m. Presentations for the CIM shall be

filed within this proceeding, along with related materials.

9. Staff of the Public Utilities Commission (Staff) shall provide a presentation at the

CIM that shall include, but is not limited to, an overview of the HCSM. Staff is directed to work

with stakeholders to finalize the agenda for the November 9, 2017, CIM. We anticipate Staff

will invite representatives from the Office of Information Technology and the Department of

Regulatory Agencies that may provide brief presentations on broadband deployment and grant

efforts. Staff may also seek engagement of consumer groups that may have an interest in the

HCSM, in addition to industry representatives that either receive or contribute to the HCSM.

10. After conferring with stakeholders and potential presenters for the November 9,

2017, CIM, Staff shall file the updated agenda within this proceeding.

II. ORDER

A. It Is Ordered That:

1. This proceeding is opened as a repository for informational materials and

presentations relating to the High Cost Support Mechanism and funding of basic voice service,

consistent with the discussion above.

2. A Commissioners' Information Meeting is scheduled for the following:


