## NATURAL GAS RATES TAX CUTS AND JOBS ACT OF 2017 ("TCJA") REFUND

The purpose of TCJA Refund is to place into effect certain adjustments to CNG's rates to reflect the impacts of the federal TCJA. Specifically, this rate reflects the lower statutory federal corporate income tax rate of 21% and places into effect the following adjustment:

CNG is placing into effect a refund to address any over collection of tax expense from January 1, 2018 through December 31, 2018 with an effective date of July 1, 2018. This adjustment is calculated using the net reduction in the total annual revenue requirements ordered in Proceeding No. 13AL-0153 using the difference between the federal corporate income tax laws in effect during the test year in that case and the federal corporate income tax laws in effect on January 1, 2018. CNG then recalculated volumetric charges using a GSRA that would have resulted from the settlement revenue requirement model in Proceeding No. 13AL-0153 at the lower federal corporate income tax rate then in effect. The refund of \$1,275,051 for the Mountain Division and \$103,790 for the Eastern Colorado Division is then applied to forecasted volumes as demonstrated in the above table reflecting the negative dollar impact per therm.

This adjustment will refund the over collection from each rate class back to that rate class apportioned pro-ratably over variable charges and will be returned to customers over the period of July 1, 2018 to December 31, 2018. If the amounts refunded are more than \$5,000 different (higher or lower), CNG will true-up the adjustment through a rate rider in effect from February 1, 2019 through February 28, 2019.
