## I. <u>BY THE COMMISSION</u>

#### A. Statement, Findings, and Conclusions

- 1. On May 21, 2019, Colorado Natural Gas, Inc. (CNG) filed an unopposed motion for an extension of time to file its Quality of Service Plan (QSP). CNG requests that the deadline be extended from the May 21, 2019 deadline, as established by Decision No. R18-0972, to June 20, 2019.
- 2. On May 15, 2018, CNG filed in this Proceeding, Advice Letter No. 89-G with supporting testimony and attachments seeking to increase its rates by \$3.8 million.
- 3. During the course of the rate case, CNG, Staff of the Colorado Public Utilities Commission (Staff), and the Colorado Office of Consumer Counsel (OCC) arrived at a Stipulation and Settlement Agreement (Settlement) resolving all issues.

- 4. As part of the Settlement, CNG and Staff agreed that both parties would collaborate to build a QSP and develop performance metrics that are appropriate for CNG and its customers. The parties also agreed that, within six months after the effective date of the final decision in this Proceeding, CNG would file a QSP, QSP Metrics, and appropriate obligations with the Commission in a separate QSP Report.
- 5. In its motion, CNG represents that it is necessary to revise its initial draft of the QSP Report and obtain further internal review and approval prior to the filing of the QSP Report with the Commission.
  - 6. CNG states that neither Staff nor the OCC are opposed to the motion.
- 7. We find good cause to grant the motion and extend the QSP Report deadline to 5:00 p.m., June 20, 2019.

#### II. ORDER

### A. The Commission Orders That:

- 1. The Unopposed Motion for Extension of Time and Modification of Decision No. R18-0972 filed by Colorado Natural Gas, Inc. on May 21, 2019 is granted, consistent with the discussion above.
  - 2. This Decision is effective upon its Mailed Date.
