GRANTING EXTENSION OF TIME**

I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a filing submitted on October 1, 2019, by Danhounsrou Transportation Services LLC, doing business as Boulder Creek Transportation (Applicant), requesting that the Commission grant a 90-day extension to comply with the terms of Decision No. R19-0657 (Decision).

2. On June 10, 2019, Applicant filed an application for permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 18, 2019. An intervention was filed and the proceeding was referred to an Administrative Law Judge on July 25, 2019.

4. On August 5, 2019, the Decision was issued, granting the application as amended. In Ordering Paragraph No. 5, the Decision set forth certain requirements, such as filing proof of insurance and an Annual Vehicle Inspection Report, that were to be completed within 60 days of

the Decision's effective date. However, the Decision also states that for good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

5. The Decision became effective on August 26, 2019. Hence, Applicant had until October 25, 2019 to comply with the Decision or file a request for additional time.

6. The instant request for additional time was timely filed on October 1, 2019. It explains that "[s]everal items on the vehicles need to be fixed in order to pass required vehicle inspection."¹

7. Therefore, the Commission concludes that good cause exists to extend the time for compliance with the requirements of the Decision for an additional 90 days from the original deadline.

II. ORDER

A. The Commission Orders That:

1. The request of Danhounsrou Transportation Services LLC, doing business as Boulder Creek Transportation, filed on October 1, 2019, that the Commission grant a 90-day extension for it to complete the requirements set forth in Decision No. R19-0657 is granted.

2. Danhounsrou Transportation Services LLC, doing business as Boulder Creek Transportation, is granted until January 23, 2020 to complete the requirements set forth in Decision No. R19-0657.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
