I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

- 1. On June 28, 2019, an application was filed for permanent authority to transfer the capital stock in Alpine Taxi/Limo, Inc., doing business as Alpine and/or Go Alpine, record owner of Certificate of Public Convenience and Necessity (CPCN) PUC No. 26246, from Lisa Adamo to the Ogilvie Family Limited Partnership.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 1, 2019, for a period of 30 days.
- 3. The 30-day notice period expired on July 31, 2019. No petition to intervene or otherwise participate in this proceeding has been filed. Therefore, this proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 4. The information submitted with this application complies with Rule 6206(c) of the Rules Regulating Transportation by Motor Vehicle, 4 Code of Colorado Regulations 723-6, and warrants the granting of the requested transfer.
- 5. The fitness of the Ogilvie Family Limited Partnership to perform the duties necessary to ensure continued adequate operations under CPCN PUC No. 26246 by Alpine Taxi/Limo, Inc., doing business as Alpine and/or Go Alpine has been satisfactorily established.
- 6. This application for approval to transfer the capital stock in Alpine Taxi/Limo, Inc., doing business as Alpine and/or Go Alpine from Lisa Adamo to the Ogilvie Family Limited Partnership is in the public interest and will be granted.

II. **ORDER**

A. **The Commission Orders That**

- This application was deemed complete on August 7, 2019, within the meaning of 1. § 40-6-109.5, C.R.S.
- 2. The application filed on June 28, 2019 for authority to transfer the capital stock in Alpine Taxi/Limo, Inc., doing business as Alpine and/or Go Alpine, record owner of Certificate of Public Convenience and Necessity (CPCN) PUC No. 26246, from Lisa Adamo to the Ogilvie Family Limited Partnership is granted.
- 3. The approved transfer of capital stock shall not be complete until Lisa Adamo and the Ogilvie Family Limited Partnership have filed with the Commission a signed acceptance of stock transfer form and have paid the applicable issuance fee of \$5.00.
- 4. If Lisa Adamo and the Ogilvie Family Limited Partnership do not comply with the requirement in Ordering Paragraph No. 3 within 60 days of the effective date of this Decision, then

the approval for the transfer of capital stock is void. For good cause shown, the Commission may

grant additional time if the request is filed within 60 days of the effective date of this Decision.

5. Alpine Taxi/Limo, Inc., doing business as Alpine and/or Go Alpine shall continue

to conduct operations under CPCN PUC No. 26246 in accordance with all applicable Colorado laws

and Commission rules.

6. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application

for rehearing, reargument, or reconsideration shall begin on the first day after the Commission

mails or serves this Decision.

7. This Decision is effective on its Mailed Date.
