I. STATEMENT

- 1. On May 8, 2019, the Commission gave notice that the above-styled proceeding has been opened. On May 10, 2019, Decision No. C19-0409 was sent to jurisdictional telecommunications carriers regarding the filing of support for Commission certification of eligible telecommunications carriers (ETCs). The Commission's decision allowed for the filing of reasonable extensions of time from the August 15, 2019 due date for support filings.
- 2. On August 13, 2019, a Motion for Extension of Time to file its ETC Annual Report was filed by San Isabel Telecom, Inc. (San Isabel). On August 15, 2019, a Motion for Extension of Time was filed by Terracom, Inc. (Terracom). Both Motions request a one-month extension of time of the August 15, 2019 deadline to September 15, 2019, for San Isabel and Terracom to file their 2019 ETC annual reports with the Commission.

- 3. As grounds for the extension of time, both companies state that gathering the components of the reports are taking more time than anticipated. In order to provide accurate information, additional time is being requested.
- 4. This miscellaneous proceeding is not contested. Therefore, response time to the Motions will be waived pursuant to Rule 1400(b) of the Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.
- 5. The Motions state good cause, and the requested extension of time to and including September 16, 2019 will be granted. September 15, 2019 falls on a Sunday.

II. ORDER

A. The Commission Orders That:

- 1. The Requests for Extension of Time to File ETC Annual Reports filed by San Isabel Telecom, Inc. and Terracom, Inc. are granted.
- 2. The deadline for filing ETC annual reports pursuant to Commission Decision No. C19-0409, is extended to and including September 16, 2019 for San Isabel Telecom, Inc. and Terracom, Inc.
 - 3. This Decision is effective immediately.
