I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On August 21, 2019, Boulders Best Transportation filed an application seeking authority to suspend operations under Contract Carrier Permit No. B-10071.¹ The requested suspension is from August 19, 2019 through August 19, 2020.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 26, 2019, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding was filed during the ten-day notice period. Therefore, this proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. In this application, Boulders Best Transportation requests a suspension of Contract Carrier Permit No. B-10071 for a period of 12 months. However in an application

submitted on July 12, 2018, Boulders Best Transportation was previously granted a suspension of operations under Contract Carrier Permit No. B-10071 from July 9, 2018 through July 9, 2019 by Decision No. C18-0632 in Proceeding No. 18A-0467BP-Suspension issued on August 2, 2018. In consideration of the previous 12-month suspension of Contract Carrier Permit No. B-10071, a suspension of operations for an additional 12 months may be excessive. Therefore, the suspension will be granted in part for a six-month period beginning on July 10, 2019.

5. The Commission finds that the information submitted with this application warrants the granting of the suspension of Contract Carrier Permit No. B-10071 for a six-month period. We also find that the application for authority to suspend Contract Carrier Permit No. B-10071 is in the public interest and will be granted in part from July 10, 2019² through January 10, 2020.

II. ORDER

A. The Commission Orders That:

- 1. This application was deemed complete on September 11, 2019, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by Boulders Best Transportation on August 21, 2019, for authority to suspend operations under Contract Carrier Permit No. B-10071 is granted in part, *nunc pro tunc*, from July 10, 2019 through January 10, 2020.
- 3. On January 11, 2020, Contract Carrier Permit No. B-10071 shall be administratively reactivated.

- 4. Prior to commencing operations, Boulders Best Transportation shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6007, 4 *Code of Colorado Regulations* 723-6; (b) pay to the Commission the motor vehicle fee for each vehicle to be operated under authority granted by the Commission; and (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.
- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 6. This Decision is effective on its Mailed Date.
