I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On December 23, 2019, Barking Squirrel Tours (Applicant) filed an application to abandon Certificate of Public Convenience and Necessity (CPCN) PUC No. 55933.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 30, 2019, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. Applicant requests approval to abandon CPCN PUC No. 55933, pursuant to Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6. However, CPCN PUC No. 55933 was properly revoked by Decision No. R19-1018, mailed on December 18, 2019, in Proceeding No. 19C-0658-INS, for Applicant's

failure to keep currently effective proof of financial responsibility on file with the Commission. Therefore, this application to abandon is most and will be denied.

II. **ORDER**

The Commission Orders That: Α.

- 1. This application was deemed complete on January 22, 2020, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by Barking Squirrel Tours on December 23, 2019 for authority to abandon Certificate of Public Convenience and Necessity PUC No. 55933 is denied as moot.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
