I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On January 13, 2020, Pikes Peak SATCOM Inc., doing business as New Inter Continental Express (Nice), filed an application to abandon operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55856.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on January 21, 2020, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. Pursuant to Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, we find that the information submitted with this application warrants the granting of the requested abandonment.

5. Therefore, we conclude that the application to abandon CPCN PUC No. 55856 is in the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. This application was deemed complete on February 5, 2020, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by Pikes Peak SATCOM Inc., doing business as New Inter Continental Express (Nice), for approval to abandon operations under Certificate of Public Convenience and Necessity PUC No. 55856 is granted.
 - 3. Certificate of Public Convenience and Necessity PUC No. 55856 is CANCELED.
- 4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 5. This Decision is effective on its Mailed Date.
