1. The fourth sentence in Paragraph 54 on page 20 of this Decision reads as follows:

Third, the proposed rule as revised directs the utility to provide a progress report on the implementation of a Commission-approved Clean Energy Plan in accordance with § 40-2-125.5(7), C.R.S. (Rule 3604(q) in the attachments to this Decision).

This sentence contains a numbering error. The reference to “Rule 3604(q)” should instead be a reference to “Rule 3604(t).” The fourth sentence in Paragraph 54 on page 20 of this Decision shall be corrected and amended as follows:

Third, the proposed rule as revised directs the utility to provide a progress report on the implementation of a Commission-approved Clean Energy Plan in accordance with § 40-2-125.5(7), C.R.S. (Rule 3604(t) in the attachments to this Decision).

2. The fifth sentence in Paragraph 54 on page 20 of this Decision reads as follows:

Fourth, the rule is revised to require the utility present an assessment of the costs and benefits of early retirements of utility-owned resources and acquisition of new utility resources required to reduce the carbon dioxide emissions associated

with the utility's sales by 80 percent from 2005 levels by 2030 (Rule 3604(k) in the attachments to this Decision).

This sentence contains a numbering error. The reference to "Rule 3604(k)" should instead be a reference to "Rule 3604(m)." The fifth sentence in Paragraph 54 on page 20 of this Decision shall be corrected and amended as follows:

Fourth, the rule is revised to require the utility present an assessment of the costs and benefits of early retirements of utility-owned resources and acquisition of new utility resources required to reduce the carbon dioxide emissions associated with the utility's sales by 80 percent from 2005 levels by 2030 (Rule 3604(m) in the attachments to this Decision).

3. The fourth sentence in Paragraph 59 on page 22 of this Decision reads as follows:

It was also intended to inform the analysis for potential early plant retirements pursuant to Proposed Rule 3604(k).

This sentence contains a numbering error. "Proposed Rule 3604(k)" should instead be a reference to "Rule 3604(l) in the attachments to this Decision." The fourth sentence in Paragraph 59 on page 22 of this Decision shall be corrected and amended as follows:

It was also intended to inform the analysis for potential early plant retirements pursuant to Rule 3604(l) in the attachments to this Decision.

4. Paragraph 69 on page 24 of this Decision reads as follows:

If adopted by the Commission, Proposed Rule 3604(k) as set forth in the NOPR would require the utility's initial ERP filing to include an assessment of potential cost-effective early retirements of utility-owned resources with retirement dates during the planning period.

This sentence contains a numbering error. "Proposed Rule 3604(k) as set forth in the NOPR" should instead be a reference to "Rule 3604(l) in the attachments to this Decision." Paragraph 69 on page 24 of this Decision shall be corrected and amended as follows:

If adopted by the Commission, Rule 3604(l) in the attachments to this Decision would require the utility's initial ERP filing to include an assessment of potential cost-effective early retirements of utility-owned resources with retirement dates during the planning period.

5. The first sentence in Paragraph 112 on page 35 of this Decision reads as follows:

The joint filing appears to support the changes in Proposed Rule 3604(k) as set forth in the NOPR, which requires an assessment of potential cost-effective early retirements of utility-owned resources.

This sentence contains a numbering error. The reference to “Proposed Rule 3604(k) as set forth in the NOPR” should instead be a reference to “Rule 3604(l) in the attachments to this Decision.” The first sentence in Paragraph 112 on page 35 of this Decision shall be corrected and amended as follows:

The joint filing appears to support the changes in Rule 3604(l) in the attachments to this Decision, which requires an assessment of potential cost-effective early retirements of utility-owned resources.

6. Footnote 41 on page 42 of this Decision reads as follows:

See Proposed Rules 3604(n) and 3614(f)(II) regarding modeling inputs and outputs.

This sentence contains a numbering error. The references to “Proposed Rules 3604(n) and 3614(f)(II)” should instead be references to “Rule 3604(s) and 3614(f)(II) in the attachments to this Decision.” Footnote 41 on page 42 of this Decision shall be corrected and amended as follows:

See Rules 3604(s) and 3614(f)(II) in the attachments to this Decision regarding modeling inputs and outputs.

7. The first sentence in Paragraph 155 on page 46 of this Decision reads as follows:

WRA recommends the Commission require that all utility studies be updated as part of each ERP cycle in Proposed Rule 3604(m).

This sentence contains a numbering error. The reference to “Proposed Rule 3604(m)” should instead be a reference to “Rule 3604(r) in the attachments to this Decision.” The first sentence in Paragraph 155 on page 46 of this Decision shall be corrected and amended as follows:

WRA recommends the Commission require that all utility studies be updated as part of each ERP cycle in Rule 3604(r) in the attachments to this Decision.

8. The first sentence in Paragraph 156 on page 47 of this Decision reads as follows:

CIEA seeks an explanation in a utility's 120-Day report of any proposed changes from the utility's previous 120-Day report as an addition in Proposed Rule 3604(n).

This sentence contains a numbering error. The reference to "Proposed Rule 3604(n)" should instead be a reference to "Rule 3604(s) in the attachments to this Decision." The first sentence in Paragraph 156 on page 47 of this Decision shall be corrected and amended as follows:

CIEA seeks an explanation in a utility's 120-Day report of any proposed changes from the utility's previous 120-Day report as an addition in Rule 3604(s) in the attachments to this Decision.
