I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. On June 25, 2020, Public Service Company of Colorado (Public Service or the

Company) filed a Motion for Approval of Alternative Form of Notice (Motion) to apply to Public

Service's Advice Letter No. 969-Gas.

2. In the Motion, Public Service states that, through Advice Letter No. 969-Gas, the

Company proposes to update the construction allowance by service class for service lateral and

distribution main extensions for all rate classes in the Company's Colorado P.U.C. No. 6-Gas

Tariff, to become effective July 26, 2020. Public Service states these changes are based on the

final Class Cost of Service Study agreed to and implemented for settlement purposes in Proceeding

No. 19AL-0309G, Public Service's 2019 Gas Phase II Rate Case. Public Service states that

customers or applicants requesting new or additional gas service from the Company may be

affected by the proposed changes.

3. The form of legal notice the Company proposes to provide is set forth in Exhibit 1

to the Motion.

4. Public Service states that, in addition to posting the legal notice on its website¹ and keeping the file open for public inspection consistent with § 40-3-104(1)(c)(I), C.R.S., the Company seeks approval to use the following alternative form of notice:

Publishing the legal notice attached as Exhibit 1 to the Motion in *The Denver Post* on a weekday during the first twenty days of the thirty-day period prior to the effective date of this change in lieu of a Sunday publication.

- 5. Public Service states the proposed weekday newspaper publication will provide the required information regarding this filing to the general public, including the estimated impact on average gas customers, while avoiding the costs associated with a Sunday publication.
- 6. Public Service states that it seeks approval of this alternative form of notice in order to avoid incurring the expense and confusion that is entailed in the other forms of statutory notice. Public Service states that its policy is to use e-mail only for significant filings, such as rate case filings. Public Service states that inundating customers with e-mail and text notifications for all filings could cause confusion. Public Service states that its customers give the Company authorization to use their e-mail and cell phone numbers for limited purposes, such as outages and conservation, rather than general use. Public Service states it has concern that frequent e-mails or texts to customers for noticing or regulatory messages could drive customers to unsubscribe or opt out from receiving e-mails or texts. Public Service explains that e-mail communications are reserved for building customer relationships through energy efficiency marketing or pre-outage communications and text messages are primarily used for outage and restoration information.
- 7. Public Service concludes that it believes the proposed alternative form of notice is sufficient to timely alert affected and interested parties of the changes proposed by its Advice Letter No. 969-Gas.

We find the alternative form of notice proposed by Public Service in its Motion to apply to Advice Letter No. 969-Gas is reasonable with respect to the Company's stakeholders and its general body of gas ratepayers. We Regulations 723-1-1207(b) of the Commission's Rules of Practice and Procedure, a utility may therefore find good cause to approve the alternative form of notice as requested by Public Service.
