I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On September 10, 2020, Manitou Springs Adventures LLC filed an application seeking approval to suspend operations under its authority, Certificate of Public Convenience and Necessity (CPCN) PUC No. 55853, from September 29, 2020 through November 10, 2020.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 14, 2020, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of a suspension of operations.

5. The application for authority to suspend CPCN PUC No. 55853 is in the public interest and will be granted.

ORDER II.

Α. **The Commission Orders That:**

- 1. This application was deemed complete on September 30, 2020, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by Manitou Springs Adventures LLC on September 10, 2020, for authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55853 is granted, nunc pro tunc, from September 29, 2020 through November 10, 2020.
- 3. On November 11, 2020, CPCN PUC No. 55853 shall be administratively reactivated.
- 4. Prior to commencing operations, Manitou Springs Adventures LLC shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 Code of Colorado Regulations 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.
- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 6. This Decision is effective on its Mailed Date.
