## I. <u>BY THE COMMISSION</u>

#### A. Statement, Findings, and Conclusions

- 1. On October 14, 2020, MTN Shuttle LLC, doing business as MTN Shuttle, filed an application seeking approval to suspend operations under its authorities, Certificate of Public Convenience and Necessity (CPCN) PUC Nos. 55764 and 55904, from October 14, 2020 through November 20, 2020, due to the COVID-19 pandemic.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 20, 2020, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of a suspension of operations.

5. The application for authority to suspend CPCN PUC Nos. 55764 and 55904 is in the public interest and will be granted.

#### II. **ORDER**

#### Α. **The Commission Orders That:**

- 1. This application was deemed complete on November 4, 2020, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by MTN Shuttle LLC, doing business as MTN Shuttle on October 14, 2020, for approval to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC Nos. 55764 and 55904 is granted, nunc pro tunc, from October 14, 2020 through November 20, 2020.
- 3. On November 21, 2020, CPCN PUC Nos. 55764 and 55904 shall be administratively reactivated.
- 4. Prior to commencing operations, MTN Shuttle LLC, doing business as MTN Shuttle, shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 Code of Colorado Regulations 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.
- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
  - 6. This Decision is effective on its Mailed Date.
