EXTENDING DEADLINES FOR  
DISPOSITIVE MOTIONS AND RESPONSES**

**I. STATEMENT, FINDINGS, CONCLUSIONS, AND ADVISEMENTS**

1. Only the relevant procedural history for this matter is provided.
2. The undersigned Administrative Law Judge (ALJ) established a procedural schedule requiring the parties to file and serve dispositive motions by February 7, 2020 and file and serve responses to dispositive motions by February 21, 2020. Decision No. R20-0031-I, issued January 14, 2020.

3. On February 5, 2020, Public Service Company of Colorado (the Company) filed an Unopposed Motion for Extension of Dispositive Motions Deadlines and Waiver of Response Time (Unopposed Motion). The Unopposed Motion seeks to extend the dispositive motions deadline to February 21, 2020 and extend responses to dispositive motions to March 6, 2020. As grounds, the Company explains that additional time is necessary to allow for further investigation to determine whether the Colorado Jewish Reconstructionists Federation (Complainant) is being billed for services through the correct natural gas meters. The parties believe the result of this investigation may bear on the appropriate outcome for their dispute. Unopposed Motion at 11-12.

4. The ALJ finds that the Unopposed Motion establishes good cause to extend the deadlines as requested, and grants the Unopposed Motion.<sup>1</sup>

## **II. ORDER**

### **A. It Is Ordered That:**

1. The deadline for parties to file and serve dispositive motions is extended to the close of business on February 21, 2020, and the deadline to file and serve responses to dispositive motions is extended to the close of business on March 6, 2020.
