**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. On January 15, 2021, Aces & Eights Casino Services, Inc. filed an application requesting the Commission authorize the suspension of Certificate of Public Convenience and Necessity (CPCN) PUC No. 48380 from January 19, 2021 through May 1, 2021.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on January 19, 2021, for a period of ten days.

3. The notice period expired on January 29, 2021. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is therefore uncontested and under § 40-6-109(5), C.R.S., may be determined without a hearing.

4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* (CCR) 723-6, the Commission finds that the information submitted by Aces & Eights Casino Services, Inc. with this application warrants the granting of a suspension of operations under CPCN PUC No. 48380.

5. The Commission also finds that the application for authority to suspend operations under CPCN PUC No. 48380 is in the public interest and will be granted.

## **II. ORDER**

### **A. The Commission Orders That:**

1. This application was deemed complete on February 3, 2021, within the meaning of § 40-6-109.5, C.R.S.

2. The application filed by Aces & Eights Casino Services, Inc. for authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 48380 is granted, *nunc pro tunc*, from January 19, 2021 through May 1, 2021.

3. On May 2, 2021, CPCN PUC No. 48380 shall be administratively reactivated.

4. Prior to commencing operations, Aces & Eights Casino Services, Inc. shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 *Code of Colorado Regulations* 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.

5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

6. This Decision is effective on its Mailed Date.
