# COMMISSION DECISION DEEMING APPLICATION COMPLETE AND GRANTING THE APPLICATION

## I. <u>BY THE COMMISSION</u>

#### A. Statement

- 1. This matter comes before the Commission for consideration of an application filed by Black Hills Colorado Gas, Inc. (Black Hills Colorado Gas or Company) on January 5, 2021 for a Certificate of Public Convenience and Necessity (CPCN) to exercise franchise rights in the Town of Cheyenne Wells, Cheyenne County, Colorado (Cheyenne Wells or Town).
- 2. The Commission provided notice of this application on January 6, 2021, to all interested persons, firms, and corporations. No petition to intervene or notice of intervention has been filed, and thus the application is uncontested. Accordingly, the application will be determined without a formal hearing in accordance with § 40-6-109(5), C.R.S., and Rule 1403, 4 *Code of Colorado Regulations* (CCR) 723-1 of the Commission's Rules of Practice and Procedure.

- 3. Black Hills Colorado Gas is engaged in, *inter alia*, the transmission, purchase, distribution, and sale of natural gas service in its certificated areas in the State of Colorado. The Town is located within such certificated areas.
- 4. Black Hills Colorado Gas requests the Commission issue a Decision granting it a CPCN to exercise franchise rights in Cheyenne Wells. Pursuant to Ordinance No. 277, adopted September 8, 2020, the Town granted Black Hills Colorado Gas a ten-year franchise to provide natural gas service within Cheyenne Wells, that will take effect the first day of the month following Commission aproval of the instant application.
- 5. On June 1, 1970, the Town granted Black Hills' predecessor, Northern Natural Gas Company, a 20-year franchise to provide natural gas service to the Town in Ordinance No. 138. On June 29, 1970, the Commission, in Decision No. 75225, granted Northern Natural Gas a CPCN to exercise franchise rights as described in Ordinance No. 138.
- 6. On May 15, 1990, the Town granted Black Hills' predecessor, Peoples Natural Gas, a 20-year franchise to provide natural gas service to the Town in Ordinance No. 199. On March 20, 1991, the Commission, in Decision No. C91-366, granted Peoples Natural Gas a CPCN to exercise franchise rights as described in Ordinance No. 199.
- 7. On September 14, 2010, the Town granted Black Hills Colorado Gas, a 20-year franchise to provide natural gas service to the Town in Ordinance No. 254. On January 6, 2011, the Commission, in Decision No. C11,0007 granted Peoples Natural Gas a CPCN to exercise franchise rights as described in Ordinance No. 254.
- 8. A utility wishing to exercise any franchise agreement or privileges entered into with a municipality must obtain a CPCN from the Commission pursuant to § 40-5-102, C.R.S. When the municipality and utility enter into a franchise agreement, that agreement must be

submitted to the Commission for approval. *See* § 40-5-102, C.R.S. Such applications allow the Commission to review franchise agreements to ensure that the terms are reasonable and in the public interest.

- 9. The Commission understands the utility and the municipality may want to revise the terms established in a franchise agreement at some point in the future and that existing franchise agreements have scheduled expiration dates. Upon negotiation of a new or amended franchise agreement, the utility shall return to the Commission in a timely manner to obtain authorization to implement the provisions of the new franchise agreement. If this franchise is not renewed at the expiration of its term or is terminated for any reason, the Company is directed to notify the Commission in a timely manner.
- 10. According to the franchise agreement, as consideration for the franchise rights granted and in recognition of Black Hills Colorado Gas' right to use the Town streets, the Town requires Black Hills Colorado Gas to collect and remit to the Town, a franchise fee of five percent of gross receipts from the sale, distribution or transportation of gas.
- 11. No other utility is authorized to provide natural gas utility service within the areas for which Black Hills Colorado Gas seeks a certificate in this application.
- 12. We find the franchise is required by public convenience and necessity and the terms of the franchise agreement are just, reasonable, and in the public interest. However, if issues of revenue requirement, cost allocation, and rate design are implicated by any provision of the franchise agreement, those issues will be analyzed in an appropriate Commission proceeding. Approval of the franchise agreement does not constitute approval of, or precedent regarding any principle or issue in revenue requirement, cost allocation, or rate design in any natural gas adjustment, refund, or rate case proceedings.

- 13. Black Hills Colorado Gas states it or its predecessors have provided gas service in the Town since the 1970, subject to relevant franchise agreements. Because the areas encompassed by the above-referenced franchises are currently served by Black Hills Colorado Gas, the Company is not required to provide a feasibility study for each area as set forth in Rule 4100(b)(VI), 4 CCR 723-4 of the Rules Regulating Gas Utilities and Pipeline Operators.
- 14. We find that Black Hills Colorado Gas has the financial ability and is qualified and competent to conduct the utility operations sought under its application.
- 15. Black Hills Colorado Gas' natural gas service tariffs, currently on file with the Commission, will be used for service under this application.
- 16. Providing uninterrupted service to the residents of Cheyenne Wells is in the public interest. Therefore, the Commission finds that the application is in the public interest and should be granted.

### II. ORDER

#### **A.** The Commission Orders That:

- 1. The application filed by Black Hills Colorado Gas, Inc. (Black Hills Colorado Gas) on January 5, 2021, for a Certificate of Public Convenience and Necessity (CPCN) to exercise franchise rights pursuant to Ordinance No. 277 in the Town of Cheyenne Wells is deemed complete and granted.
- 2. The granting of the CPCN to operate under the terms of this franchise agreement is in the public interest and in accordance with the terms of § 40-5-102, C.R.S.
- 3. The franchise agreement between Black Hills Colorado Gas and the Town of Cheyenne Wells and the rights and obligations associated therewith is scheduled to expire on March 1, 2041.

- 4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails this Decision.
  - 5. This Decision is effective upon its Mailed Date.
