I. Transportation of passengers and their baggage, in scheduled service, between all points in Denver, Colorado, on the one hand, and all points within a 12-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, on the other hand, via any combination of the following roads or highways: Interstate Highway 25, Colorado State Highways 7, 66, and 72, U.S. Highways 34, 36, and 85, 104th and 120th Avenues, Tower Road, Pena Boulevard, Highway E-470, and the Northwest Parkway; serving all intermediate points between Lyons (inclusive) and Estes Park, Colorado; and serving as intermediate points, (a) all points in Boulder, Colorado, (b) all points within 1/4 mile of the intersection of Colorado State Highway 66 and U.S. Highway 287, (c) all points within 1/4 mile of the intersection of U.S. Highway 34 and U.S. Highway 287, and (d) all points within 1/4 mile of the intersection of U.S. Highway 34 and Interstate Highway 25.

# <u>RESTRICTIONS</u>: Item I. is restricted as follows:

- A. To serving only points named in the carrier's schedule on file with the Commission.
- B. To the use of vehicles with a seating capacity of ten passengers or more, not including the driver, when providing service over any of the following routes: U.S. Highways 34 and 85, the Northwest Parkway, Tower Road, and 104th and 120th Avenues;
- C. To the use of vehicles with a seating capacity of ten passengers or more, not including the driver, when providing service to or from points in Denver, Colorado, other than Denver International Airport;
- D. Against providing service between Denver, Colorado, and Boulder, Colorado; and
- E. Against providing service between Denver, Colorado, and all points within 1/4 mile of the intersection of Colorado State Highway 66 and U.S. Highway 287.
- II. Transportation of passengers and their baggage, in scheduled service, between all points in Denver, Colorado, on the one hand, and, on the other hand, all points within twelve miles of Estes Park, Colorado, that are outside a 12-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, via any combination of the following roads or highways: Interstate Highway 25, Colorado State Highways 7 and 66, U.S. Highways 34, 36, and 85, 104th and 120th Avenues, Tower Road, Pena Boulevard, Highway E-470, and the Northwest Parkway; serving all intermediate points between Lyons (inclusive) and Estes Park, Colorado, and serving as intermediate points (a) all points in Boulder, Colorado, (b) all points within 1/4 mile of the intersection of Colorado State Highway 66 and U.S. Highway 287, (c) all points within 1/4 mile of the intersection of U.S. Highway 34 and Interstate Highway 25 as intermediate points.

# RESTRICTIONS: Item II. is restricted as follows:

- A. To serving only points named in the carrier's schedule on file with the Commission;
- B. To the use of vehicles with a seating capacity of ten passengers or more, not including the driver;
- C. Against providing service between Denver, Colorado, and Boulder, Colorado; and
- D. Against providing service between Denver, Colorado and all points within 1/4 mile of the intersection of Colorado State Highway 66 and U.S. Highway 287.

- III. Transportation of passengers and their baggage, in call-and-demand sightseeing service, between all points within a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, and between said points, on the one hand, and all points within a 75-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, on the other hand.
- IV. Transportation of passengers and their baggage, in call-and-demand sightseeing service, between all points within twelve miles of Estes Park, Colorado, on the one hand, and that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line, on the other hand.

#### **RESTRICTIONS:**

- A. Item IV. is restricted against service to or from points within a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado.
- V. Transportation of passengers and their baggage, in call-and-demand limousine service, between all points within a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, and between said points, on the one hand, and all points within a 75-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, on the other hand.
- VI. Transportation of passengers and their baggage, in call-and-demand limousine service, between all points within twelve miles of Estes Park, Colorado, on the one hand, and Boulder, Colorado, and that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line, on the other hand.

# **RESTRICTIONS:**

A. Item VI. is restricted against service to or from points within a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado.

VII. Transportation of passengers and their baggage, in charter service, between all points within 12 miles of Estes Park, Colorado.

# **RESTRICTIONS:**

A. For service that originates or terminates in the area outside a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, Item VII. is restricted to the use of vehicles with a seating capacity of 15 passengers or less, not including the driver, unless the service originates or terminates in the County of Boulder.

VIII. Transportation of passengers and their baggage, in charter service, between all points within 12 miles of Estes Park, Colorado, on the one hand, and all points within a 75-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, on the other hand.

# RESTRICTIONS:

A. For service that originates or terminates in the area that is (a) outside a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, and (b) within 12 miles of Estes Park, Colorado:

- 1. Item VIII. is restricted to the use of vehicles with a seating capacity of 15 passengers or less, not including the driver, unless service originates or terminates either in Boulder, Colorado, or that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line; and
- 2. Item VIII. is restricted against service that originates or terminates in Boulder County, unless service originates or terminates either in Boulder, Colorado, or that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line
- B. For service that originates in the City and County of Denver, Colorado, and terminates in the area that is (a) outside a 10-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, and (b) within 12 miles of Estes Park, Colorado, Item VIII. is restricted to a point of origination at Denver International Airport.
- IX. Transportation of passengers and their baggage, in charter service, between all points within 12 miles of Estes Park, Colorado, on the one hand, and all points outside a 75-mile radius of the intersection of U.S. Highways 34 and 36 in Estes Park, Colorado, on the other hand.

# RESTRICTIONS: Item IX. is restricted as follows:

- A. To the use of vehicles with a seating capacity of 15 passengers or less, not including the driver, unless service is between points within 12 miles of Estes Park, Colorado, on the one hand, and points either in Boulder, Colorado, or that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line, on the other hand.
- B. Against points of origin in the City and County of Denver, Colorado, other than Denver International Airport.
- C. Against service originating or terminating in Lake County.
- D. Against service to or from Boulder County, unless service is between points within 12 miles of Estes Park, Colorado, on the one hand, and points either in Boulder, Colorado, or that portion of Boulder County which lies north of a line beginning at the intersection of Colorado State Highway 52 and the Boulder-Weld County line, thence west over Colorado State Highway 52 as extended to the Boulder-Grand County line, on the other hand.
