INTERIM COMMISSION DECISION GRANTING THOMAS H. ROWLAND'S MOTION FOR PRO HAC VICE ADMISSION

I. BY THE COMMISSION

- A. Statement, Findings, and Conclusions
- 1. On January 11, 2021, Thomas H. Rowland filed a Verified Motion to Appear *Pro Hac Vice* on behalf of Resound Networks, LLC. (Motion).
- 2. An attorney who is not licensed to practice law in Colorado must be granted permission to appear *pro hac vice* in this Proceeding. Rule 1201(a) of the Commission's Rules of Practice and Procedure 4 *Code of Colorado Regulations* (CCR) 723-1, governs the admission of out-of-state attorneys. Rule 1201(a) requires compliance with Colorado Rule of Civil Procedure (CRCP) 205.4, which itself expressly incorporates CRCP 205.3.
- 3. As pertinent here, CRCP 205.3(2)(a) details what an out-of-state attorney must do to be permitted to appear *pro hac vice* and includes these requirements:
 - (a) File a verified motion with the administrative agency requesting permission to appear;

- (b) Designate an associated attorney who is admitted and licensed to practice law in Colorado;
- (c) File a copy of the verified motion with the Clerk of the Supreme Court Office of Attorney Regulation at the same time the verified motion is filed with the administrative agency;
- (d) Pay the required fee to the Clerk of the Supreme Court collected by the Office of Attorney Regulation; and
 - (e) Obtain permission from the administrative agency for such appearance.
- 4. In his January 11, 2021 Motion, Mr. Rowland attested to the requirements above and proof of *pro hac vice* registration was subsequently filed January 28, 2021.
- 5. Mr. Rowland meets the requirements of CRCP 205.4. We therefore grant Mr. Rowland's request to appear *pro hac vice*.

II. ORDER

A. It is Ordered That:

- 1. The Verified Motion to Appear *Pro Hac Vice* by Thomas H. Rowland filed January 11, 2021, is granted, consistent with the discussion above.
 - 2. This Decision is effective on its Mailed Date.
