I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On April 15, 2021, R&R DIA Shuttle Service, LLC filed an application to abandon operations under its Certificate of Public Convenience and Necessity (CPCN) PUC No. 55938.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on April 19, 2021, for a period of ten days.
- 3. The notice period expired on April 29, 2021. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

¹ CPCN PUC No. 55938 authorizes the transportation of passengers in call-and-demand shuttle service between all points in the Counties of Adams, Arapahoe, Denver, Douglas, El Paso, Elbert, and Weld, State of Colorado.

- 4. In support of this suspension application, the manager of R&R DIA Shuttle Service, LLC states there is no business due to the pandemic.
- 5. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the Commission finds that the information submitted by R&R DIA Shuttle Service, LLC with this application warrants the granting of the abandonment of operations under CPCN PUC No. 55938.
- 6. The Commission also finds that the application for authority to abandon operations under CPCN PUC No. 55938 is in the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. This application was deemed complete on May 5, 2021, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by R&R DIA Shuttle Service, LLC on April 15, 2021, for approval to abandon operations under Certificate of Public Convenience and Necessity PUC No. 55938 is granted.
 - 3. Certificate of Public Convenience and Necessity PUC No. 55938 is canceled.
- 4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 5. This Decision is effective on its Mailed Date.
