**INTERIM DECISION ADOPTING PROPOSED  
PROCEDURAL SCHEDULE, ADOPTING PROCEDURES  
FOR DISCOVERY AND CONFIDENTIAL INFORMATION,  
AND VACATING THE PREHEARING CONFERENCE**

**I. BY THE COMMISSION**

**A. Statement**

1. On May 7, 2021, Public Service Company of Colorado (Public Service or the Company), Staff of the Colorado Public Utilities Commission, the Colorado Office of Consumer Counsel, and the Colorado Energy Office (together, the Joint Movants) filed an Unopposed Joint Motion to adopt a procedural schedule, adopt procedures for discovery and confidential information, vacate the prehearing conference, and waive response time (Joint Motion).

2. By this Decision, we adopt the procedural schedule proposed in the Joint Motion, adopt the proposed procedures for discovery and confidential information, and vacate the prehearing conference scheduled to be held on May 12, 2021.

**B. Discussion**

3. On February 9, 2021, Public Service filed an Application to extend its Pipeline System Integrity Adjustment (PSIA), a volumetric rider applied to customers of the Company's gas division, through 2024.

4. In Decision No. C21-0271-I, mailed May 4, 2021, the Commission set the matter for hearing *en banc*, scheduled a prehearing conference to be held on May 12, 2021, required the Company to confer with the parties and file a proposed procedural schedule prior to the prehearing conference, and “[i]n the interests of procedural efficiency and to create a complete and useful record,”<sup>1</sup> required the Company to file Supplemental Direct Testimony in response to seven prompts for elaboration on the PSIA Application.

5. On May 7, 2021, the Joint Movants timely filed the following proposed procedural schedule:<sup>2</sup>

6. The Joint Movants state a final prehearing conference is not necessary and that logistical matters normally handled on such occasions can be addressed on the first day of

hearing. The Joint Movants also defer to the Commission the dates for public comment hearings, whether virtual or in-person.

7. The Joint Movants also agree to certain modifications to discovery timelines and procedures set forth in Rules 1405(b) and 1405(d) of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1, including: discovery requests and responses will be served electronically; discovery responses shall be served in a single document per discovery set if available when due; receipt of confidential and highly confidential documents and discovery response will require signing a non-disclosure agreement; and any workpapers supporting Supplemental Direct, Answer, Rebuttal, or Cross-Answer Testimony are to be provided within three business days of the respective filing.

8. The Joint Movants request the Commission approve the proposed procedural schedule and vacate the prehearing conference scheduled for May 12, 2021. The Joint Movants also request, given the Joint Motion is unopposed, that the Commission waive response time to the Joint Motion.

### **C. Findings and Conclusions**

9. We find the proposed procedural schedule to be reasonable with one clarification: because the Commission is closed on September 6, 2021 in observance of the Labor Day holiday, the Matrix of Witness Appearances and Cross-Examination Times shall be filed on the following day.

10. We adopt the proposed procedural schedule and the proposed procedures for discovery and treatment of confidential information as set forth in the Joint Motion.

11. Because we adopt a procedural schedule by this Decision, we also find it reasonable to vacate the prehearing conference scheduled for May 12, 2021.

12. The evidentiary hearings will be held using the web-hosted video conferencing service Zoom unless subsequently modified. To minimize the potential that the video conference may be disrupted by non-participants, the link and meeting ID or access code will be provided to the parties by e-mail before the prehearing conference, and the parties will be prohibited from distributing that information to anyone not participating in the prehearing conference.

13. Information and directions on using Zoom to attend the remote prehearing conference is provided in Attachment A to this Decision. The Commission strongly encourages the parties to test their ability to use Zoom before the scheduled start time.

## **II. ORDER**

### **A. It Is Ordered That:**

1. The Unopposed Joint Motion to adopt a procedural schedule, adopt procedures for discovery and confidential information, vacate the prehearing conference, and waive response time (Joint Motion) filed by Public Service Company of Colorado, Staff of the Colorado Public Utilities Commission, the Colorado Office of Consumer Counsel, and the Colorado Energy Office on May 7, 2021 is granted. Response time to the Joint Motion is waived.

2. The procedural schedule and the procedures for discovery and confidential information as set forth in the Joint Motion is adopted, consistent with the discussion above.

3. The prehearing conference scheduled for May 12, 2021 is vacated.

4. An evidentiary hearing in this matter is scheduled as follows:

DATES: September 13, 14, and 15, 2021

TIMES: 9:00 a.m. through 5:00 p.m. (September 13 and 14, 2021); and  
1:00 p.m. through 5:00 p.m. (September 15, 2021)

PLACE: By video conference using Zoom at a link to be provided to parties by email.

5. This Decision is effective upon its Mailed Date.
