

## COLORADO NATURAL GAS, INC.'S ADDITIONAL NOTICE OF FILING AN APPLICATION FOR A PROPOSED SAFETY SYSTEM INTEGRITY RIDER ("SSIR")

You are hereby notified that Colorado Natural Gas, Inc. ("CNG" or "Company"), 10825 E. Geddes Ave, Suite 410, Centennial, Colorado 80112, has filed with the Public Utilities Commission of the State of Colorado ("Commission"), in accordance with the Public Utilities Law, an application for approval of a safety system and integrity rider ("SSIR"). The purpose of this Application is to place into effect an infrastructure investment rider –the SSIR – to be included as part of the Company's Colorado PUC No. 2 gas tariff. The SSIR mechanism would allow the Company to recover on a current basis the costs associated with certain investments made pursuant to its pipeline safety and integrity programs, including investments to accelerate the replacement of higher risk pipe and mitigate other safety issues identified on the Company's natural gas system. The Company is proposing to place SSIR rates into effect based on the annual revenue requirement calculated of plant investments projected to be placed in service under the SSIR Programs during calendar year 2021. Based on the information available at the time of the Application, the rate and bill impacts resulting from implementation of new SSIR rates in 2022 are as follows:
