**I. STATEMENT****A. Relevant Background**

1. A more complete summary of the history of this proceeding to date is included in Decision Nos. R20-0595-I, R20-0889-I, and R21-0038-I. The background relevant to this decision is included below.

2. On December 14, 2020, the Administrative Law Judge issued Decision No. R20-0889-I that, among other things, scheduled the hearing for January 25-26, 2021 and established the deadline of February 10, 2021 for Statements of Position (SOPs) and briefs filed by *amicus curiae*.

3. On February 9, 2021, Complainant Utilities Board of the City of Lamar (LUB) filed an Unopposed Motion to Extend Due Date for the Filing Parties' Statements of Position and Amici's Legal Briefs to February 16, 2021 (Unopposed Motion). As support, LUB states that due to the timing of its receipt of the transcript of the hearing and the COVID-19 vaccine and the resulting side-effects, it is requesting an extension to February 16, 2021 to file its SOP.

**B. Analysis**

4. LUB has stated good cause to grant the Unopposed Motion. Accordingly, the Unopposed Motion shall be granted and the deadline to file SOP's and *amicis*' briefs shall be extended to February 16, 2021.

**II. ORDER****A. It Is Ordered That:**

1. For the reasons stated above, the Unopposed Motion to Extend Due Date for the Filing Parties' Statements of Position and Amici's Legal Briefs to February 16, 2021 filed by

Complainant Utilities Board of the City of Lamar is granted. The deadline for the parties to file their Statements of Position and for *amici* to file their legal briefs is extended to February 16, 2021.
