I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission for consideration of an application (Application) filed by the City of Fort Collins (Fort Collins) on July 22, 2022, requesting authority to relocate a railroad signal bungalow and vacation of the associated easement at the Cherry Street crossing of the BNSF Railway Company (BNSF) at railroad milepost 74.52 of the Front Range Subdivision, National Inventory No. 244642N in Fort Collins, County of Larimer, State of Colorado.

2. The Commission gave notice of this Application (Notice) to all interested parties, including adjacent property owners pursuant to § 40-6-108(2), C.R.S. The Notice was mailed July 25, 2022.

3. On August 24, 2022, BNSF filed a Notice of Intervention. BNSF opposes and contests the Application and requested a hearing in this matter. BNSF states that the Application makes a request that exceeds Commission jurisdiction.

4. The Commission reviewed the record in this matter and deems the Application complete pursuant to § 40-6-109.5, C.R.S.

5. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.

6. Now being fully advised in the matter, we refer the Application to an Administrative Law Judge for disposition of the intervention and a determination of the merits of the Application.

II. ORDER

A. It Is Ordered That:

1. The application (Application) filed by the City of Fort Collins (Fort Collins) on July 22, 2022, requesting authority to relocate a railroad signal bungalow and vacation of the associated easement at the Cherry Street crossing of the BNSF Railway Company (BNSF) at railroad milepost 74.52 of the Front Range Subdivision, National Inventory No. 244642N in Fort Collins, County of Larimer, State of Colorado is deemed complete within the meaning of § 40-6-109.5, C.R.S.

2. Proceeding No. 22A-0334R is referred to an Administrative Law Judge of the Colorado Public Utilities Commission for disposition of the interventions and determination of the merits of the Application.
