#### I. <u>BY THE COMMISSION</u>

#### A. Statement, Findings, and Conclusions

- 1. On August 25, 2022, Bee Line, LLC filed an application to abandon operations under its Certificate of Public Convenience and Necessity (CPCN) PUC No. 55798.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 29, 2022, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. Pursuant to Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, we find that the information submitted with this application warrants the granting of the requested abandonment.
- 5. Therefore, we conclude that the application to abandon CPCN PUC No. 55798 is in the public interest and will be granted.
