**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a motion submitted on December 1, 2022, by MedRide, LLC (Applicant), requesting that the Commission reopen the proceeding and allow additional time to comply with the terms of Decision No. C22-0555 (Decision).

2. On July 6, 2022, Applicant filed an application for permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 1, 2022. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On September 20, 2022, the Commission issued the Decision and granted the permanent authority, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and a vehicle inspection report; and register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date of September 20, 2022, to comply with the Order; otherwise, "the CPCN is denied without further action of the Commission." Therefore, Applicant had until November 21, 2022 (the sixtieth day, November 19, 2022, was a Saturday) to complete the terms of the Decision. Applicant did not comply with all the requirements; thus, the proceeding was closed without the CPCN being issued.

7. In the motion submitted on December 1, 2022, Applicant requests that the Commission reopen the proceeding, grant additional time, and accept the late-filed documents. Applicant explains that it "failed to file the requested supplemental documentation on the November 21, 2022, due date as a result of calendaring errors and the holidays but filed such documents and requested information on November 23, 2022."

8. The Commission concludes that good cause exists to grant an additional 30 days to comply with the Decision.

**II. ORDER**

**A. The Commission Orders That:**

1. The motion filed on December 1, 2022, by MedRide, LLC, requesting that the Commission reopen the proceeding and allow additional time to comply with the terms of Decision No. C22-0555, is granted.

2. MedRide, LLC is granted 30 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C22-0555.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
