**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a filing submitted on December 19, 2022, by eTuk Denver LLC, doing business as eTuk Ride (Applicant), requesting that the Commission grant an additional 120 days to comply with the terms of Decision No. C22-0702 (Decision).

2. On September 8, 2022, Applicant filed an application for permanent authority to extend operations under its Certificate of Public Convenience and Necessity (CPCN) PUC No. 55861.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 19, 2022. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On November 9, 2022, the Commission issued the Decision and granted the permanent authority, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit a new advice letter with tariff; and, register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date of November 9, 2022, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On December 19, 2022, Applicant timely filed the instant request for an additional 120 days to comply with the Decision. Applicant explains that "[t]his will allow us more time to select vehicles to be used in our expanded authority."

8. The Commission concludes that good cause exists to grant Applicant's request for an additional 120 days to comply with the Decision.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The request of eTuk Denver LLC, doing business as eTuk Ride, filed on December 19, 2022, that the Commission grant an additional 120 days to complete the requirements set forth in Decision No. C22-0702 is granted.

2. eTuk Denver LLC, doing business as eTuk Ride, is granted 120 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C22-0702.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
