DISMISSING APPLICATION**

I. STATEMENT

1. On July 14, 2022, Applicant, eTuk Denver LLC, doing business as eTuk Ride (eTuk), filed the Application at issue in this proceeding to extend its authority under Certificate of Public Convenience and Necessity Number 55861.

2. On July 25, 2022, the Public Utilities Commission (Commission) gave notice of the Application.

3. Four entities filed Interventions: Mountain Star Transportation LLC dba Explorer Tours (Explorer Tours); Ckimy LLC dba ilimo (ilimo); Ullr Tours, llc dba The Colorado Sightseer (Colorado Sightseer); and Aspire Tours LLC (Aspire Tours).

4. On August 31, 2022, the Commission deemed the Application complete and referred the matter to an Administrative Law Judge (ALJ) for disposition.

5. On October 17, 2022, eTuk advised the Commission by letter that it was “withdraw[ing] and clos[ing]” this Application. eTuk further advised that on September 12, 2022, it filed a new Application to extend its operations under Certificate of Public Convenience

and Necessity No. 55861. eTuk's letter advising the Commission of the withdrawal and closing of this Application will be treated as a motion to withdraw the Application it filed on July 14, 2022.

6. Having reviewed eTuk's motion to withdraw, the undersigned ALJ finds and concludes that good cause has been shown for eTuk's request and that no party will be prejudiced by the dismissal of this Application and the closing of this proceeding. The response time to the motion to withdraw will therefore be waived. eTuk's motion to withdraw the Application it filed on July 14, 2022, will be granted and this proceeding will be closed.

II. ORDER

A. It Is Ordered That:

1. The response time to the motion to withdraw is waived.
2. The motion filed by eTuk Denver LLC to withdraw and close the Application it filed on July 14, 2022, is granted.
3. The Application of eTuk Denver LLC filed on July 14, 2022, is dismissed and Proceeding No. 22A-0326CP-EXT is closed.
4. This Decision is effective immediately.
