**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of approval of eight Corrective Action Plans (“CAP”) that were submitted by the Denver Metro area Regional Transportation District light rail operation that occurred between January 1, 2025, and March 31, 2025. A report summarizing the CAP was filed by Staff of the Public Utilities Commission (“Staff”) on May 21, 2025.

2. The CAPs to be reviewed by the Commission are CAP01-12292024, CAP01-01092025, CAP01-01142025, CAP01-01252025, CAP01-01292025, CAP01-02242025, CAP01-03312025 and CAP02-03312025 for final approval and monitoring to closure.

3. This matter also comes before the Commission for consideration of five CAPs that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAPs filed by Staff on May 21, 2025.

The CAP numbers reviewed by the Commission for closure are CAP09-11132020, CAP01-01232024, CAP01-02292024, CAP01-09112024 and CAP01-10032024.

4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the CAPs and recommendations for final approval and monitoring to closure of the eight new CAPs, and for closure of the five existing open CAPs.

5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The Commission provides final approval of and monitoring to closure of CAP01-12292024, CAP01-01092025, CAP01-01142025, CAP01-01252025, CAP01-01292025, CAP01-02242025, CAP01-03312025 and CAP02-03312025 submitted by the Denver Metro area Regional Transportation District light rail operations and closure of CAP09-11132020, CAP01-01232024, CAP01-02292024, CAP01-09112024 and CAP01-10032024.

2. This Decision is effective immediately upon its Issued Date.
