APPLICATION AND CLOSING PROCEEDING**

I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission for consideration of a Motion of the City of Wheat Ridge to Withdraw Application (“Motion”) filed by the City of Wheat Ridge (“Wheat Ridge”) on July 9, 2025, requesting to withdraw its application in this matter.

2. The Commission approved the Application as amended by Interim Decision No. C24-0591-I, issued August 20, 2024.

3. Wheat Ridge filed its Motion for Extension of Time 9.5.24, which was granted by the Commission by Interim Decision No. C24-0691-I, issued September 26, 2024, allowing Wheat Ridge until December 30, 2024, to file the final plans for this project by December 30, 2024. Final plans were not filed by this date.

4. As grounds for the Motion to withdraw its Application, Wheat Ridge states that it determined that it cannot now proceed with this project for funding and related reasons. Because of these reasons, Wheat Ridge requests to withdraw its Application.

5. No responses were filed to the Motion.

6. Now being fully advised in the matter, we grant the Motion

II. ORDER

A. The Commission Orders That:

1. The Motion of the City of Wheat Ridge to Withdraw Application filed by the City of Wheat Ridge (“Wheat Ridge”) on July 9, 2025, is granted.

2. The Application of the City of Wheat Ridge to construct a new grade separated crossing is closed.

3. This Decision is effective upon its Issued Date.
