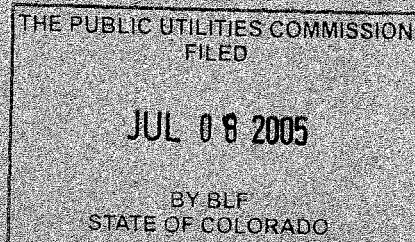

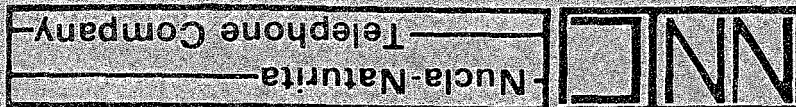
PRINCIPAL PROPOSED CHANGES

The intrastate and special access changes contained in these tariff revisions are in order to comply with the Rules Prescribing the Standard Procedures for Separating the Property Costs, Revenues, Expenses, Taxes, and Reserves for Access Charges of Rural Telecommunications Providers (4 CCR 723-27).

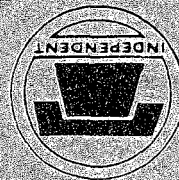
Concurrent with these tariff changes, the Company is requesting to re-establish its level of support from the Colorado High Cost Fund under the Rules Prescribing the Procedures for Administering the Colorado High Cost Fund (4 CCR 723-41). The Company qualifies for \$63,919 of support for High Cost Loops (Rule 18.1) and \$167,686 of support for High Exchange Trunk Costs (Rule 18.3). Accordingly, the Company seeks to re-establish support in the amount of \$231,605 from the Colorado High Cost Support Mechanism.

EFFECT ON UTILITY REVENUES

It is anticipated that the Company's revenues will increase by \$216,357, producing an overall intrastate rate-of-return of 6.93%. The Company anticipates its proposed intrastate access rates will generate an additional \$64,094 in revenues -- specifically, \$56,296 in switched access and \$7,798 in special access. The amount support requested from the Colorado High Cost by the Company represents an increase of \$152,263 over its current draw.

EFFECT ON CUSTOMERS

The Company is not seeking an increase in local rates in this filing, accordingly, residential and business customers will not be impacted. However, the Company has proposed changing certain intrastate access rates. Impacted customers are being notified of the proposed changes. A certificate of notification will be sent under separate cover.

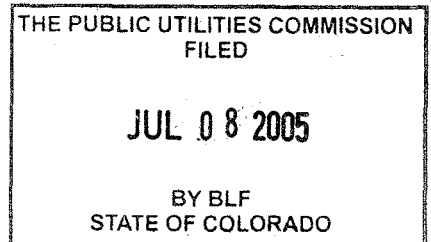

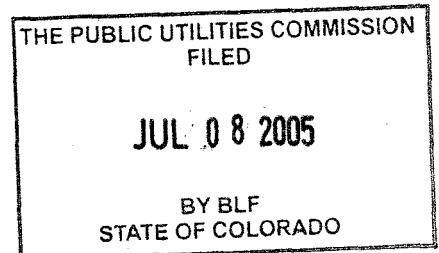

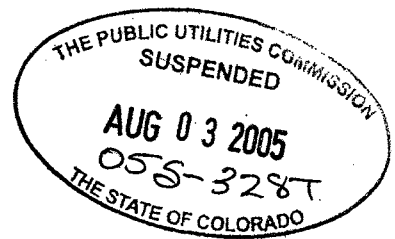

PROTEST AND REQUEST FOR HEARING
OF THE COLORADO OFFICE OF CONSUMER COUNSEL

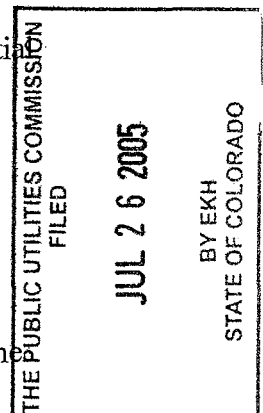
The Colorado Office of Consumer Counsel ("OCC"), by and through its undersigned counsel, submits the following Protest and Request for Hearing in the above-captioned matter. As grounds therefore, the OCC states:

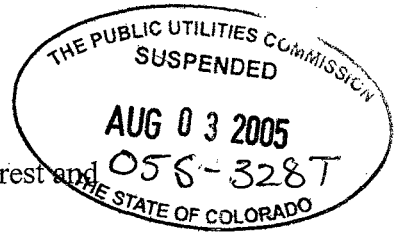
1. On or about July 7, 2005, Nucla-Naturita Telephone Company ("Nucla-Naturita" or the "Company") filed Advice Letter No. 82 seeking to increase intrastate and special access rates and also requesting an increase in its support from the Colorado High Cost Support Mechanism ("CHCSM").

2. Advice Letter No. 82 does not propose to increase retail rates, but the increased support from the CHCSM would affect retail customers who contribute to the CHCSM.

3. Advice Letter No. 82 affects the constituency the OCC is statutorily mandated to represent pursuant to C.R.S. § 40-6.5-104, as Nucla-Naturita serves residential, agricultural, and small business customers in Colorado.

4. The OCC requests that Advice Letter No. 82 be suspended and set for Hearing. The reason for the OCC's request is based upon Nucla-Naturita's proposed increased support from the CHCSM. A hearing is necessary to determine if granting the





access rate increase and CHCSM support increase would be in the public interest and would result in just and reasonable rates.

5. This protest is timely filed.

6. The OCC requests that copies of all pleadings, correspondence, notices, rulings, orders, decisions, testimony, exhibits, discovery, and/or notices of any open meetings relating to this proceeding be forwarded to:


