NOTICE OF A CHANGE IN THE ELECTRIC RATES OF
PUBLIC SERVICE COMPANY OF COLORADO
1225 17TH STREET, DENVER, COLORADO 80202

You are hereby notified that Public Service Company of Colorado has filed with the Colorado Public Utilities Commission to change electric rates for all customers through the Air Quality Improvement Rider (AQIR), to become effective January 1, 2008, unless suspended by the Public Utilities Commission.

The AQIR rate is different for each of three customer groups: Group 1 consists of all residential customers and commercial and industrial customers taking service at secondary voltages; Group 2 consists of commercial and industrial customers taking service at primary and transmission voltages; and Group 3 consists of lighting service customers. The proposed AQIR rates are:

Group 1	\$0.00108/kWh
Group 2	\$0.47/kW
Group 3	\$0.00111/kWh

The effect on the Company's annual revenue will be an increase of \$6,101,283 based upon projected sales for the twelve-month period January 1, 2008 through December 31, 2008. The revised AQIR rates proposed above are filed in compliance with Commission Decision No. R99-678 in Docket No. 98A-511E and Decision No. C02-1422 in Docket No. 02S-485E. The proposed changes in the AQIR rates are increases for Groups 1, 2 and 3. The average monthly impact for customers by rate class is projected to be as follows:

The change in the AQIR will also affect the Wind Energy Service Adjustment because the AQIR is credited against the Wind Energy Rate in order to calculate the Wind Energy Service Adjustment. No change is being proposed to the Wind Energy Rate. The proposed changes in the Wind Energy Service Adjustments are as follows:

Customers who subscribe to Wind Energy Service should see no change in their bills for the kilowatt-hours of Wind Energy Service.

The proposed and present tariffs are available for examination and explanation at the business office of Public Service Company located at 1225 17th Street, Suite 1000, Denver, Colorado 80202 and at the Public Utilities Commission of the State of Colorado, located at 1560 Broadway, Suite 250, Denver, Colorado 80202.

Anyone who desires may file written objection. The filing of a written objection by itself will not allow you to participate as a party in any proceeding on the proposed rate changes.

If you wish to participate as a party in any proceeding established in these matters, you must file written intervention documents under applicable rules.

Anyone who desires to file written objection to the proposed action, shall file it with the Colorado Public Utilities Commission, 1560 Broadway, Suite 250, Denver, Colorado, 80202 at least ten days before the proposed effective date of January 1, 2008.

The Public Utilities Commission may hold a hearing to determine what rates, rules and regulations will be authorized. If a hearing is held, the Commission may suspend the proposed rates, rules or regulations.

The rates, rules and regulations ultimately authorized may or may not be the same as those proposed and may include rates higher or lower than those proposed or currently in effect.

Anyone who desires to receive notice of any hearing, shall file a written request for notice with the Public Utilities Commission, at the above address at least ten days before the proposed effective date.

If a hearing is held, any member of the public may attend and may make a statement under oath about the proposed decrease, whether or not he or she has filed an objection or intervention.
