STIPULATED MOTION OF HOME JAMES TRANSPORTATION SERVICES, LTD., VALLEY TAXI, INC. AND COLORADO TOUR TRANSPORTATION, LLC (A) TO RESTRICTIVELY AMEND THE APPLICATION, (B) FOR WITHDRAWAL OF INTERVENTION CONTINGENT UPON ACCEPTANCE OF THE RESTRICTIVE AMENDMENT, (C) REQUEST TO PROCESS AND GRANT THE AMENDED APPLICATION UNDER MODIFIED PROCEDURE UNDER RULE 1403 (C), AND (D) FOR WAIVER OF THE RESPONSE TIME TO THE STIPULATED MOTION

Home James Transportation Services, Ltd. ("Home James" or "Transferor"), Valley Taxi, Inc. ("Valley Taxi" or "Transferee") (Home James and Valley Taxi may also be referred to herein jointly as "Applicants"), and Colorado Tour Transportation, LLC ("CTT" or "Intervenor") file their above stipulated motion to restrictively amend the application, for withdrawal of the Intervention contingent upon acceptance of the restrictive amendment, to process and grant the amended application under modified procedure under Rule 1403 (c), and for waiver of the response time to the stipulated motion. In support thereof, Applicants and CTT state as follows to the Colorado Public Utilities Commission (PUC or Commission):

Background

By this application Home James seeks PUC authority to transfer a portion of Certificate No. 16114 to Valley Taxi. The application was noticed in the PUC's Notices of April 14, 2008 and a copy of the PUC's Notice of the application is attached hereto as Exhibit A. A copy of Certificate No. 16114 in its entirety is attached hereto as Exhibit B. The intervention period has expired and CTT is the only intervenor to the application. Its interest in the application is minimal as its only authority in conflict is its Certificate No. 55712 a copy of which is attached

hereto as Exhibit C. On May 23, 2008, Applicants file a motion to strike the CTT intervention and or other relief. On or about May 30, 2008, CTT filed its reply. The Applicants and CTT have been engaged in settlement negotiations. The purpose of this stipulated motion is to advise the PUC that the parties have reached a settlement which, if approved by the PUC, will (1) restrictively amend the application, will satisfy the interest of the intervenor and will enable the application to be granted, as amended, under the PUC's modified procedure in Rule 1403 (c).

Stipulated Motion to Restrictively Amend the Application, for withdrawal of CTT's Intervention contingent upon acceptance of the restrictive amendment, and to process and grant the amended application under modified procedure under Rule 1403 (c).

Home James, Valley Taxi and CTT request that the application be restrictively amended to eliminate all geographic overlap between the Certificate of CTT and the authority Home James seeks to transfer to Valley Taxi, for withdrawal of the intervention of CTT contingent upon acceptance of the restrictive amendment, and to process and grant the amended application under modified procedure under Rule 1403 (c). Subsequent to the offered restrictive amendment to the application the authority to be transferred to Valley Taxi is as shown on Exhibit D attached and the authority to be retained by Home James will be as shown on Exhibit E attached. Both Valley Taxi and Home James consent to this restrictive amendment by their respective representatives' signatures on this stipulated motion and CTT consents to withdrawal of its intervention if the restrictive amendment is granted by its representative's signature on this motion.

The intent and effect of the restrictive amendment is to remove the geographic overlap between the authority of CTT in its Certificate No. 55712 and the authority being transferred to Valley Taxi. The parties recognize that this will result in a "split" of various parts of the authority under Certificate No. 16114, but advise the PUC that it is their understanding that since

the repeal and recodification of the PUC's Rules regarding transportation carriers that became effective in April, 2006 (and as subsequently amended) issues regarding a "split of authority" in a certificate, especially in a case that is otherwise unopposed, no longer exist. The current rules clearly contemplate that only a portion of a certificate may be involved in a transfer. See Rule 6205 (c) (IV). Further, in the current version of the rules, the burden of proof that the Applicants have under Rule 6205 (e) does not specifically include issues relating to "splits of authority". The parties believe that this is in recognition that in the underlying statutes, the PUC is can issue a certificate "for the partial exercise only of the privilege sought..." (Section 40-10-105 (1), C.R.S.) and that the PUC can transfer "rights obtained under any such certificate" (Section 40-10-106, C.R.S.). The parties submit this stipulated motion under Rule 1408 of the PUC's rules as a negotiated settlement of the parties and request that it be approved.

Wherefore, the parties request that the above portions of their stipulated motion be granted as requested.

Stipulated Request for Waiver of the Response Time to the Motion

The parties request that the response time to their within motion be waived as there are no parties to respond to it.

WHEREFORE, Applicants respectfully request that their stipulated motion be granted as requested in its entirety and that the application also be granted as amended.




