I, TED BARRETT, declare as follows:

- 1. I am an adult and permanent resident of the State of Colorado. If called upon to do so, I could testify competently to the matters stated herein.
- 2. I am employed by the Public Utilities Commission (Commission) of the State of Colorado. I make this affidavit in my capacity as a Criminal Investigator for the Commission's Trial Advocacy Staff.
- 3. In my capacity as a Criminal Investigator I have access to the Commission's official records. These records are maintained in digital format and are searchable using a variety of criteria.
- 4. In November 2009, I was assigned to investigate Respondent Paul H. Epler d/b/a Action Towing as a result of a complaint filed with the Commission by Ms. Nicole Taylor.
- 5. As part of my investigation, I obtained a news article dated September 26, 2009 stating that tow company owner Paul Henry Epler was convicted of a felony charge of theft.

- 6. I also conducted a Colorado court database search for information related to Respondent. The search revealed that on September 25, 2009, Respondent was found guilty of a Class 4 Felony for Theft in Case # 2009CR000917 in El Paso County. See Exhibits 1 & 2.
- 7. I obtained the Arrest Warrant as well as the Application and Affidavit for Arrest Warrant from the El Paso County District Court.
- 8. I also contacted the Colorado Springs Police Department and requested the police report related to the incident. In response to the request, I received Police Report # C09-05766.
- 9. My investigation revealed that Mr. Epler was operating as a towing carrier under permit # T-2601 in 2009.
- 10. On January 21, 2009, Mr. Epler towed a 1997 GMC Pick Up truck that was attached to a 1997 Wanderer Camper Trailer to his storage lot.
- 11. On February 2, 2009, Mr. Epler picked the lock to the trailer and discovered the deceased body of the owner.
- 12. The police were contacted to investigate the cause of death. The owner's next of kin were contacted to retrieve the property.
- 13. During the course of the Coroner's investigation and prior to the next of kin taking possession of the vehicle, Mr. Epler removed and took possession of certain belongings from the trailer.
- 14. Mr. Epler additionally took steps to hinder the next of kin from removing the property from his storage lot.

- 15. After an investigation by the Colorado Springs Police Department, Mr. Epler was charged with theft per § 18-4-401, C.R.S., a class four felony.
- 16. On September 25, 2009, Mr. Epler was convicted of theft per § 18-4-401 C.R.S., a class 4 felony.
- 17. Pursuant to Court records and the Colorado Springs Police Report, the felony was essentially committed during Mr. Epler's operation as a towing carrier. Belongings from a towed trailer stored in Mr. Epler's storage lot were removed and not returned to their rightful owner.
- 18. Mr. Epler was convicted of a felony directly related to his operation as a towing carrier under a permit issued by the Commission.

I declare under penalty of perjury under the laws of the State of Colorado that the foregoing is true and correct of my own knowledge.
