Dear Mr. Dean:

In compliance with the requirements of the Public Utilities Law of Colorado, SourceGas Distribution LLC ("SourceGas Distribution") hereby submits for filing with the Public Utilities Commission of the State of Colorado (the "Commission") the following revisions to its Colorado Schedule of Rates for Natural Gas Service Available in the Entire Territory Served by SourceGas Distribution LLC, designated the "Colorado PUC No. 7 Tariff" and abbreviated therein as "Colo. PUC No. 7" (the "Tariff"). Exhibits I and II to this Advice Letter filing, respectively, are clean and redlined versions of all Tariff changes.

Basis for Filing, Proposed Effective Date and Notice

SourceGas Distribution is making this Advice Letter No. 261 filing to address the changes to its Tariff that result from the proposals included in the general rate case recently filed by SourceGas Distribution's affiliate Rocky Mountain Natural Gas LLC ("Rocky Mountain") as part of Advice Letter No. 77, which the Commission has designated Docket No. 13AL-0067G. Rocky Mountain provides service to SourceGas Distribution's Western Slope Rate Area.

SourceGas Distribution's proposed Tariff revisions fall into six categories:

1. Revision of the Sales Rate Schedule, Distribution Transportation Rate Schedule, General Terms and Conditions and related forms of agreement to comport with Rocky Mountain's proposed restructuring and unbundling of services
2. Addition of agency forms related to Limited Term Partial Assignment of capacity held by SourceGas Distribution on Rocky Mountain's system
3. Modification of the Litigated Settlement Special Rate Surcharge provisions of the Tariff
4. Addition of a Working Gas Storage Cost component to SourceGas Distribution's Gas Cost Adjustment mechanism applicable to the Western Slope Rate Area
5. Revision of gas quality standards for consistency with upstream gas quality standards
6. Minor housekeeping changes such as correcting misspelling and minor clarifications to existing provisions

The proposed Tariff revisions to the Rate Schedules, General Terms and Conditions and related forms of agreement will address upstream requirements on Rocky Mountain's system and will not change the rates charged to or the revenues received from customers on SourceGas Distribution's system in the Western Slope Rate Area.

The proposed effective date of the revisions described in this filing is Wednesday, May 1, 2013. SourceGas Distribution will give notice of this filing to its customers in the Western Slope Rate Area and its Distribution Transportation Service customers in the Form of Notice provided with this Advice Letter filing as Exhibit III.

Direct Testimony and Exhibits Supporting This Filing

SourceGas Distribution's proposals in this Advice Letter filing are presented through and supported by the direct testimony and exhibits of the following three witnesses that accompany this Advice Letter filing.

- Mr. James M. Elliott: Mr. Elliott addresses categories 3 through 6 described above.

- Mr. Eric G. Fritz: Mr. Fritz explains how SourceGas Distribution plans for upstream capacity and describes the process for providing customers with access to SourceGas Distribution capacity in order to purchase gas supply from competitive marketers.¹
- Mr. Richard A. Maceyka: Mr. Maceyka addresses categories 1 and 2 described above.
