The Company files Advice No. 839 - Gas to make changes to the Service Lateral Extension and Distribution Main Extension Policy in the Company's P.U.C. No. 6 - Gas Tariff related to its current line extension policy. The policy is being updated to reflect changes over time.

The Company is proposing the following changes to the Service Lateral Extension and Distribution Main Extension Policy:

- a) Modify the existing methodology for calculating the Service Lateral and Distribution Main construction allowances.
- b) Introduce new tariff provisions to address Uneconomic Extensions and service territory boundary changes.
- c) Refining the Construction Payment provisions that will allow specific governmental entities a waiver from the requirements that they pay the Construction Payment in its entirety before the Company initiates work on their behalf.
- d) New tariff language that provides Natural Gas Vehicle Fueling Stations an opportunity to be awarded Construction Allowance as load increases.
- f) The introduction of new tariff provisions concerning the installation of Excess or Uneconomic Facilities and the amount of an Excess Facilities/Uneconomic Facilities Charge.
