I. <u>BY THE COMMISSION</u>

A. Statement

- 1. On March 7, 2014, Public Service Company of Colorado (Public Service or Company) filed an Unopposed Motion for Extension of Time to File the 2013 PSIA Annual Report (Motion). Public Service requests that it be permitted to file its 2013 PSIA Annual Report on May 1, 2014, instead of April 1, 2014, as required pursuant to the May 25, 2011 Settlement Agreement in this Proceeding No. 10AL-963G approved in Decision No. C11-0946, mailed September 1, 2011.
- 2. The Company states that an extension of this deadline is warranted in order to allow Public Service sufficient time to develop and incorporate the additional information that it has agreed to include in its annual reports in the additional Stipulation and Agreement (Settlement Agreement) filed in this proceeding on February 25, 2014, and the joint comments filed in Proceeding No. 13M-0915G on January 24, 2014.

- 3. Public Service states that the other parties to the Settlement Agreement, the Staff of the Colorado Public Utilities Commission and the Office of Consumer Counsel, do not oppose this Motion.
- 4. We agree that a one month extension of the 2013 PSIA Annual Report is warranted, given the recent developments in this proceeding and Proceeding No. 13M-0915G.

II. ORDER

A. It Is Ordered That:
