**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of a Motion for Permission to Amend Application (Motion) filed by the Regional Transportation District (RTD) on May 22, 2014, requesting to amend its application requesting to modify the Park Avenue/22nd Street overpass to include a protective barrier along the roadway bridge over the tracks at the subject crossing, to renumber existing Exhibit C to Exhibit C-1, and add Exhibits C-2 through C-6 showing typical sections and details for the proposed protective barrier.

2. Review of the new exhibits shows that RTD proposes to install a protective barrier along the bridge rails that provides a protective screening for any users of the Park Avenue/22nd Street viaduct over the location of the new RTD commuter rail tracks.

3. No responses were filed to the Motion.

4. Now being fully advised in the matter, we find that good cause exists to grant the Motion and require construction of a protective barrier on the Park Avenue/22nd Street viaducts at the location of the new RTD commuter rail tracks.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The Motion for Permission to Amend Application (Motion) filed by the Regional Transportation District (RTD) on May 22, 2014, requesting to amend its application requesting to modify the Park Avenue/22nd Street overpass to include a protective barrier along the roadway bridge over the tracks at the subject crossing, to renumber existing Exhibit C to Exhibit C-1, and add Exhibits C-2 through C-6 showing typical sections and details for the proposed protective barrier is granted.

2. RTD is authorized and ordered to proceed with construction of a protective barrier on the structures of the Park Avenue/22nd Street overpass as shown in Exhibits C-2 through C-6 of the Motion.

3. The 20-day period provided for in § 40-6-114, C.R.S., within which to file applications for rehearing, reargument, or reconsideration, begins on the first day following the effective date of this Decision.

4. The Commission retains jurisdiction to enter further decisions as necessary.

5. This Decision is effective on its Mailed Date.
