I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusion

- 1. On July 11, 2014, the City and County of Denver (City) filed a motion requesting an extension of time (Motion) to file its signed Construction and Maintenance Agreement (Agreement). The City requests the Commission approve an extension of time to September 15, 2014, in which to file the Agreement.
- 2. In support of its Motion, the City states that by Decision No. C14-0451, the Commission approved the City's application in this proceeding and ordered the City to file a signed copy of the Agreement with the Commission by May 31, 2014.
- 3. The City represents that the City, Denargo Market, L.P., and the Union Pacific Railroad Company (Union Pacific) are currently negotiating the Agreement for the improvements approved by the Commission in this proceeding. The City is optimistic that the

Agreement will be finalized within the next couple of months and therefore requests an extension of time until September 15, 2014, to file the signed Agreement with the Commission.

4. Union Pacific filed its intervention in this matter on April 8, 2014, and the Regional Transportation District (RTD) filed its intervention April 14, 2014. Neither Union Pacific nor RTD filed a response or opposition to the request for additional time to file the Agreement. We find good cause exists to grant the extension of time requested in the Motion. The City shall file & page 4.

II. ORDER

A. The Commission Orders That:

- 1. The Motion for Extension of Time filed by the City and County of Denver, requesting the Commission approve an extension of time to September 15, 2014, in which to file the signed Construction and Maintenance Agreement, is granted.
