TO RESCHEDULE HEARING**

**I. STATEMENT**

1. By Interim Decision No. R14-0100-I, issued January 24, 2014, a procedural schedule was adopted which, among other things, scheduled an evidentiary hearing for March 10 and 11, 2014.

2. On February 28, 2014, Colorado Cab Company LLC, doing business as, Denver Yellow Cab and Boulder Yellow Cab (Colorado Cab) filed an Unopposed Motion to Reschedule Hearing and Request to Waive Response Time (Motion).

3. According to the Motion, Colorado Cab requests that the hearing in this proceeding currently scheduled for March 10 and 11, 2014 be rescheduled. Colorado Cab states that two of its principal witnesses will not be able to attend the hearing on the currently scheduled dates which would substantially prejudice its case. As a result, Colorado Cab requests that the current hearing date be vacated and reset to April 8 and 9, 2014. Colorado Cab represents that it has discussed this matter with Applicant MT Acquisitions, LLC,

doing business as Mountains Taxi, and Applicant consents to rescheduling the hearing. Colorado Cab also requests that response time to the Motion be waived.

4. While good cause is found to grant the motion to reschedule the hearing, the undersigned Administrative Law Judge is unavailable on April 8, 2014. Therefore, the hearing will be rescheduled to April 9 and 10, 2014. Response time to the Motion will be waived. The remainder of the procedural schedule will remain as adopted in Interim Decision No. R14-0100-I.

**II. ORDER**

**A. It Is Ordered That:**

1. The Unopposed Motion to Reschedule Hearing and Request to Waive Response Time (Motion) filed by Colorado Cab Company LLC, doing business as, Denver Yellow Cab and Boulder Yellow Cab is granted in part consistent with the discussion above.

2. The evidentiary hearing scheduled for March 10 and 11, 2014 is vacated.

3. An evidentiary hearing is scheduled as follows:
