I. STATEMENT

1. On November 1, 2013, High Country Shuttle Inc. (Applicant), filed the above-captioned application.

2. The Commission provided public notice of the Application on November 4, 2013.

3. On December 4, 2013 Colorado Coach Transportation LLC and MT Acquisitions LLC, doing business as Mountains Taxi (collectively, interveners), timely intervened of right (by separate filings).

4. During the Commission's weekly meeting held December 11, 2013, the Commission deemed the Application complete and referred it to an administrative law judge (ALJ) for disposition.

5. On February 19, 2014, the matter was scheduled for a hearing on the merits of the Application for April 3 and 4, 2014 at the Commission's office in Denver, Colorado. Decision No. R14-0187-I.

6. On March 7, 2014, Applicant filed a Motion seeking to move the hearing location to Georgetown, Colorado. Interveners filed an objection to the Motion that same day.

7. In order to resolve the Applicant's Motion in an expedited manner, the ALJ will hold a telephone hearing on the Motion as set forth below.¹

8. The ALJ will contact the parties at the telephone number they have provided to the Commission at the date and time designated below.

9. All parties are expected to appear at the hearing by telephone.

10. Failure to appear could result in denial of the relief the party seeks with respect to Applicant's Motion to move the hearing location.

II. ORDER

A. It Is Ordered That:

1. A telephone hearing regarding Applicant's Motion to move the hearing location is scheduled as follows:
