**I. STATEMENT**

1. On March 28, 2014, Public Service Company of Colorado filed its Application for a Certificate of Public Convenience and Necessity for the Pawnee to Daniels Park 345kV Transmission Project and for Specific Finding with Respect to EMF and Noise.

2. By Decision No. C14-0553-I issued May 23, 2014, the matter was referred to an administrative law judge to conduct a public comment hearing and for preparation of a recommended decision.

3. The Commission found good cause to conduct a public comment hearing in this proceeding. The Commission also specifically recognized that some of the comments filed specifically request that the Commission convene a hearing in the Town of Parker.

4. The public comment hearing will be scheduled to permit the comments to testimony in the proceeding. To the extent the public wishes to provide comment later in the proceeding, written comments will be accepted.

Therefore, all parties will be precluded from making statements at a public comment hearing.
