I. STATEMENT

1. This proceeding concerns Civil Penalty Assessment Notice (CPAN) No. 109242 issued by Staff of the Colorado Public Utilities Commission (Staff) on June 26, 2014 against Respondent Royal Blue Car Service, LLC (Royal Blue). The CPAN assessed Royal Blue a total penalty of \$4,840.00 for six violations of the *Rules Regulating Transportation by Motor Vehicle, 4 Code of Colorado Regulations* (CCR) 723-6, including an additional 10 percent surcharge. CPAN No. 109242 was served upon Respondent on June 26, 2014.

2. The matter was referred to an Administrative Law Judge (ALJ) for resolution by minute entry during the Commission's Weekly Meeting held July 23, 2014.

3. In order to assist the undersigned in preparing for hearing and understanding the legal issues to be decided, Staff will be ordered to disclose whether any of Staff's counts in the CPAN allege violation of a safety rule promulgated by the Commission.

4. Any party wishing to make an oral closing statement may do so immediately following the close of the evidence (*i.e.*, after presentation of evidence near the end of the hearing).

5. **All parties are advised** that this proceeding is governed by the Rules of Practice and Procedure found at 4 CCR 723-1, Part 1. The ALJ expects the parties to comply with these rules. The rules are available on the Commission's website (www.dora.state.co.us/puc) and in hard copy from the Commission.

6. Each party is specifically reminded that all filings with the Commission must also be served upon all other parties in accordance with *Rule 1205 of the Rules of Practice and Procedure*, 4 CCR 723-1.

II. **ORDER**

A. **It Is Ordered That:**

1. On or before September 17, 2014, Staff of the Commission shall make a filing disclosing whether any of Staff's counts in the CPAN allege violation of a safety rule promulgated by the Commission.

2. A hearing in this matter shall be conducted at the following date, time, and place:
