I. STATEMENT

A. Background

- 1. On April 1, 2019, Public Service Company of Colorado (PSCo) filed its 2018 Pipeline System Integrity (PSIA) Annual Report.
- 2. On April 29, 2019, Staff of the Public Utilities Commission (Staff) filed a challenge to the projects and costs contained in the report. As part of that challenge, Staff requested that the Commission set the 2018 Annual PSIA Report for hearing in accordance with the procedures outlined in paragraphs 63 and 64 of Decision No. R14-0694.
- 3. On May 21, 2019, the Commission issued Decision No. C19-0431 that referred this proceeding to an Administrative Law Judge (ALJ). The proceeding was subsequently assigned to the undersigned ALJ.

B. Prehearing Conference

procedural schedule established, and to the hearing dates scheduled during the prehearing

conference.
